## Report on One Day Workshop on: “Advocacy, Courtroom Skill, Constitutional Aspects and Professional Ethics”

The Internal Quality Assurance Cell (IQAC) of R.L. Law College, Davangere, under Bapuji Educational Association (Regd.), organised a One Day Workshop on "Advocacy, Courtroom Skill, Constitutional Aspects and Professional Ethics" on 26<sup>th</sup> May 2026. The college is affiliated to Karnataka State Law University, recognised by the Bar Council of India, and accredited with B+ Grade by NAAC.

The workshop was conducted with the following objectives:

- To equip students with practical courtroom skills and advocacy techniques.
- To create awareness about key constitutional provisions relevant to legal practice.
- To instil the values of professional ethics and etiquette required for the legal profession.
- To provide exposure to judicial perspective through interaction with a sitting judge.

Prof. B.P. Basavanagowda, Principal, presided over the function and emphasised the importance of practical training for law students. Dr. M. Somashekarappa, Director, graced the occasion. The Resource Person, Sri Aditya R. Kalal, delivered an insightful session covering:




1. Advocacy & Courtroom Skills: Art of examination of witnesses, drafting, argument techniques, and courtroom demeanour.
2. Constitutional Aspects: Practical application of fundamental rights, directive principles, and judicial review in litigation.
3. Professional Ethics: Duties of advocates towards court, client, opponent, and society as per Bar Council of India rules. He shared real-life examples from the Bench to explain ethical dilemmas faced by advocates.

The session was followed by an interactive Q&A where students clarified doubts on moot court preparation, internship opportunities, and career in judiciary. The workshop was attended by the Principal, Director, teaching and non-teaching staff, and students of R.L. Law College, Davangere. The presence of a judicial officer as resource person made the session highly relevant and engaging.

### Outcome

1. Students gained practical knowledge of courtroom procedure directly from a judicial officer.
2. The workshop bridged the gap between theoretical study and professional practice.
3. It reinforced the importance of ethics and constitutional values in legal practice.
